## Open House Well Attended



## LPA Moves Forward



The locally preferred alternative (LPA), which includes the selection of bus rapid transit as the mode and a route, will be discussed in the coming weeks by government entities along the route.

Comments received during the LPA process will be used to inform a recommendation of the final LPA by the Gateway Corridor Policy Advisory Committee (PAC) to the Gateway Corridor Commission. Both the PAC and the Commission meet Sept. 11.

After the PAC and the Commission take action on the final LPA, six cities and two counties along the corridor will be requested to pass a resolution of support for the LPA for it to be included in the final version of the Metropolitan Council's 2040 Transportation Policy Plan.

About the Gateway Corridor Commission: The Commission was created in 2009 to study and plan alternative transportation options for the area along Interstate 94 in the eastern metro of the Minneapolis-Saint Paul region. The Commission is comprised of local elected officials and business leaders. The Commission in early 2013 identified a preferred route for a fixed-guideway alternative in the Gateway Corridor. The project seeks to improve transit service from the Union Depot in Saint Paul to the eastern metro, while providing a focal point for more concentrated development as the region grows.
